

WESTMORLAND AND FURNESS COUNCIL (VARIOUS TOWNS AND VILLAGES IN THE
EDEN LOCALITY AREA) (CONSOLIDATION AND PROVISION OF SPEED LIMITS)
ORDER 2025 NO. 2

1. Westmorland and Furness Council hereby give notice that it proposes to make the above Order under Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of the Police, in accordance with Part III of Schedule 9 to the Act.
2. The effect of the proposed Order will be to consolidate the provisions of The Westmorland and Furness Council (Various Towns and Villages in the Eden Locality area) (Consolidation and Provision of Speed Limits) Order 2025 and amend the Order to include the following proposals, into one concise order: -

(a) Lengths of Roads subject to 20mph speed limit:-

Askham-

- i. The entire lengths of U3175, U3176 and U3177
- ii. Parts of C3043 and C3046

Crosby Ravensworth-

- i. Parts of C3054, C3058, U3250 Bank Head & Bank Lane, U3250 Silver St, U3442 Tenter Row and U3761 Stoneworks Garth

Dufton

- i. Parts of C3065

Glenridding

- i. The entire lengths of U3744 Barraclough Fold and U3376 Eagle Road
- ii. Parts of A592 and U3456

King's Meaburn

- i. Parts of C3057

Nenthead

- i. Parts of U3116 Loop Road and U3116 Fiddlers Bank

Orton

- i. The entire lengths of U3648 Frankland Park and U3275
- ii. Parts of B6260, B6261 (West End Rd), B6261 (Front St), B6261 and U3276

Ousby

- i. Parts of C3004, C3009 and U3099

Patterdale

- i. The entire length of U3458
- ii. Part of A592

Ravenstonedale

- i. The entire length of U3409
- ii. Parts of C3075, U3410 and U3570 (north loop)
