WESTMORLAND AND FURNESS COUNCIL (VARIOUS ROADS, SOUTH LAKELAND AREA) (CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2023) VARIATION ORDER NO. 1 2025

- 1. Westmorland and Furness Council hereby give notice that on 4th March 2025 it made the above Order under Sections 1(1) and 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.
- 2. The Order will come into operation on 10th March 2025 and its effect will be to introduce the following:
 - a. Ulverston Priory Road, Co-Op proposed 'no waiting at any time' (double yellow line) restrictions (Plan SLTR2023.001.01 Restriction A),
 - b. Ulverston Priory Road, Leisure Centre proposed 'no waiting at any time' (double yellow line) restrictions (Plan SLTR2023.001.02 Restriction B & C),
 - c. Heversham proposed closing of gap at location G between two 'no waiting at any time' (double yellow line) restrictions (Plan SLTR2023.001.04.LB.01 Restriction D-G).
 - d. Kendal Greenside (North) proposed legitimisation of existing parking arrangements following the installation of a Bus Stop build-out (Plan SLTR2023.001.04 H and I).
 - e. Kendal Greenside (South) proposed legitimisation of existing parking arrangements following the installation of a new junction layout (Plan SLTR2023.001.05 (J and K).
