NOTICE OF APPLICATION TO TRANSFER A RIGHT OF COMMON IN GROSS

Notice is hereby given that an application has been made **Adam Thomas Richards** ("the Applicant") to Westmorland and Furness Council as Commons Registration Authority, under Section 12 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL29 Coniston Fell, Dunnerdale Fell, Seathwaite Fell, Torver High Common.

A summary of the effect of the application is as follows:

The right to graze 399.81 sheep and followers over the part of the land comprised in this register unit lying south of the line A-B on the register map; stock may be exchanged at the rate of 2 geese for 1 sheep, 10 sheep for 1 cow or 2 cows for 1 horse ("the Right") is currently registered as held in gross (not attached to land) at entry 100 of register unit CL29 in the name of Andrew John Nicholson and James David Nicholson.

The Applicant claims that the Right was transferred to them by way of a Deed dated 01 April 2025. The transfer does not operate at law until registered by the Commons Registration Authority in the register. The Applicant seeks by this application to complete the transfer of ownership and register the Right in their name.

If the application is granted, in whole or in part, the Commons Registration Authority will give effect to the determination by making a new entry in the register showing the Applicant as the owner of the Right amounting to 399.81.

Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 26 May 2025.
