NOTICE OF APPLICATION TO TRANSFER A RIGHT OF COMMON IN GROSS

Notice is hereby given that an application has been made by **Christopher John Wilson, Peter Steven Wilson and Richard William Wilson** ("the Applicants") to Cumberland Council as Commons Registration Authority for CL20 Caldbeck Common ("CL20"), and Westmorland and Furness Council as Commons Registration Authority for CL60 Carrock Fell & Mungrisdale Common ("CL60"), under Section 12 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

A summary of the effect of the application is as follows:

The right to graze 140 ewes and shearlings and 50 hogs on Bowscale Fell, comprising part of the land in register unit CL60, and on the land in unit CL20 south of DE, north of AB and east of BC ("the Right"), is currently registered as held in gross (not attached to land) at entries 204 and 26 of commons register units CL20 and CL60 respectively.

The Applicants claim that the Right was transferred to them by way of a Deed dated 5th September 2025. The transfer does not operate at law until registered by the Commons Registration Authority in the register. The Applicants seek by this application to complete the transfer of ownership and register the Right in their names.

If the application is granted, in whole or in part, the Commons Registration Authority will give effect to the determination by making a new entry in the register showing the Applicants as the owners of the Right.

Any person wishing to make representations:

- must quote the Application No. **CA6/227**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and


Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on **17th November 2025**.
