

**WESTMORLAND AND FURNESS COUNCIL (VARIOUS ROADS BARROW
INFURNESS AND SURROUNDING AREA) (CONSOLIDATION AND PROVISION OF
SPEED LIMITS)
(ORDER 2024) VARIATION ORDER NO. 1 202x**

Westmorland and Furness Council, in exercise of its powers under Sections 82,83, and 84 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police, in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. Commencement and Citation

- a. This Order shall come into operation on >< 20>< and may be cited as the Westmorland and Furness Council (Various Roads, Furness Area) (Consolidation and Provision of Speed Limits) (Order 2024) Variation Order No. 1 20><.
- b. In this Order, the expression 'the 2024 Order' means the Westmorland and Furness Council (Various RoadsFurness Area) (Consolidation and Provision of Speed Limits) Order 2024.
- c. The provisions of any other Order, Byelaw or enactment relating to the speed restrictions on the lengths of road specified in the Schedules hereto and not specifically referred to in this Order are hereby revoked and the provisions of this Order shall prevail for all purposes.
- d. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- e. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
- f. In accordance with Section 87 of the Act, no speed limit imposed by this Order shall apply to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that speed limit would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion.

2. Revocations to the 2024 Order

- a. The provisions of the 2024 Order are hereby revoked as specified in Schedule 1 to this Order.

3. Speed Limits Insertions to the 2024 Order

- a. Lengths of road subject to 20mph speed limit
Schedule 1 of the 2024 Order is hereby varied by the insertion of the items, in the appropriate place, as set out in Schedule 2 to this Order.

SCHEDULE 2 Lengths of road subject to 20 mph Speed Limit

Hawcoat and Newbarns ward

- (1) The entire lengths of the following (unless specified otherwise):-
Back Baldwin Street, Badgers Court, Baldwin Street, Birstall Road, Bridgegate Avenue Service Road, Cowlams Road, Darley Dale Road, Denton Road, Derbyshire Road, Devonshire Road (from its junction with Thorncliffe Road to a point 64m west of its junction with Victoria Avenue), Elterwater Crescent, Ennerdale Drive, Furness Park Road (from its junction with Thorncliffe Road to its junction with Oxford Street), Gladstone Terrace, Grantley Road, Greystoke Gardens, Hare Ghyll, Hare Lane, Harrogate Street, Hartland Road, Hawcoat Lane (from its junction with Abbey Road to its junction with Dalton Lane), Head Meadow, Hempland Avenue, Hill Road, Kendall Croft, Laurence Avenue, Lichfield Close, Little Croft, Matlock Road, Middle Hill, Middleton Avenue, Norland Avenue, Oxford Street (from its junction with Victoria Avenue to its junction with Hawcoat Lane), Portland Crescent, Risingside, Rusland Avenue, Sandringham Close, Skelwith Drive, St Mary's Road, St Quintin Avenue, Stackwood Avenue, Thorncliffe Park, Thorncliffe Road, Threlkeld Gardens, Thurlow Way, Undergreens Road, Victoria Avenue (from its junction with Devonshire Road to its junction with Oxford Street), Wheatclose Road, Woodlands Park, Woodward Avenue, Yewdale Avenue

Old Barrow and Hindpool ward

- (2) The entire lengths of the following (unless specified otherwise):-
Brewery Street, Buccleugh Court, Buccleugh Street (from its junction with Rawlinson Street to its junction with Thwaite Street), Cavendish Street (from its junction with Rawlinson Street to its junction with Gradwell Court, Mill Street, Thwaite Street, Whitehead Close, Whitehead Street,

Risedale and Roosecote ward

- (3) The entire lengths of the following (unless specified otherwise):-
Bolton Street, Cambridge Street (from its junction with St Lukes Road to its eastern end point), St Lukes Road (from its junction with Moorfield Street to its junction with Roose Road,

Walney Island ward

- (4) The entire lengths of the following (unless specified otherwise):-
Anzac Avenue, Black Butts Lane (from its junction with Sandy Gap Lane to its junction with Bristol Street), Cows Tarn Lane, Falmouth Street, Moor Tarn Lane (from its junction with Sandy Gap Lane to its junction with Southport Drive), Sandy Gap Lane (from its junction with Weymouth Street to its western end point), Shaefell View, Verdun Avenue, Weymouth Street.
