(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2023)
VARIATION ORDER (NO. 4) 20><

1. Westmorland and Furness Council hereby give notice that it proposes to make the above Order under Sections 1(1) and 2(1) to (4), 32, 35, 35A, 45, 46, 47, 49, 51, 53 and 64 of the Road Traffic Regulation Act 1984 (RTA Act) and Part IV of Schedule 9 of the RTA Act and all other enabling provisions under the RTA Act and all other enabling acts.
2. The effect of the proposed Order will be to introduce the following restrictions, as part of the **A595 Grizebeck Improvement Scheme**: -
 - vi) no waiting at any time (double yellow line) on the U5958 [former] A595;
 - vii) prohibition of motor vehicles (except for access) on the C5013;
 - viii) prohibition of motor vehicles (except for access) on the C5014 Buckhorn Lane;
 - ix) prohibition of entry for northbound traffic only – U5958 Grizebeck Garage Service Road; and
 - x) prohibition of entry for southbound traffic only – U5958 Grizebeck Garage Service Road
