Westmorland and Furness Council, in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("RTA Act") and of all other enabling provisions under the RTA Act and all other enabling acts, and after consultation with the Chief Officer of Police, in accordance with Part III of Schedule 9 to the RTA Act hereby makes the following Order: -

**1. Commencement and Citation**

- (2) In this Order, the expression 'the 2023 Order' means the Cumbria County Council (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2023).
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**3. Revocations to the 2023 Order**

- (1) The provisions to the 2023 Order are hereby revoked as specified in Schedule 2 to this Order.

In so far as any provisions of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act, or by or under any other enactment, then the provisions of this order shall prevail.
