PUBLIC SPACES PROTECTION ORDER 2025 NO.007 (VARIATION)

TO PUBLIC SPACES PROTECTION ORDER 2024 NO.004 (FIRES, BARBEQUES, VEHICLES AND STRUCTURES)

ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014

THIS ORDER is made by Westmorland and Furness Council (“the Council”) in exercise of its powers under section 61 of the Anti-Social Behaviour, Crime and Policing Act 2014 (“the Act”), hereby makes the following Order:-

1. Citation and Commencement

THIS ORDER may be cited as the Public Spaces Protection Order (Fires, Barbeques, Vehicles and Structures) (Variation) 2025 No.007 and shall come into force on 08 January 2026.

2. Variation to Public Spaces Protection Order 2024 No.004

The Council hereby varies the Public Spaces Protection Order 2024 No.004 (Fires, Barbeques, Vehicles and Structures) (“the Original Order”) as follows:

2.1 Amendment to Clause 2.1 and 2.2 of the Original Order

Clause 2.1 of the Original Order is hereby deleted and replaced with the following:

2.1 UNAUTHORISED FIRES AND BARBEQUES

2.1.1 Fires or barbeques are prohibited by this Order within the areas identified in Schedule 1 and Schedule 2B, unless prior written consent has been obtained from the Council or the National Trust.

Clause 2.2 of the Original Order is hereby deleted and replaced with the following:

2.2 VEHICLES AND STRUCTURES

- 2.2.1 A person shall be guilty of an offence if at any time they drive or permit a vehicle to be used in a manner that causes or is likely to cause harassment, alarm, distress or danger to persons, within the area listed in Schedule 2A, unless prior written consent has been obtained from the Council.
- 2.2.2 No person shall position any vehicle, campervan, motorhome, caravan, tent or any other temporary structure designed or intended to provide shelter or accommodation for the purpose of an overnight stay or stays, within the areas listed in Schedule 2A and Schedule 2B, unless prior written consent has been obtained from the Council or National Trust.
- 2.2.3 The person with responsibility for, or utilising, any vehicle or temporary structure shall immediately remove the same and/or any associated equipment, animals or other material from the land as specified in Clause 2.2.2 above, upon request from an Authorised Officer.

2.2 Replacement of Schedule 2

- 2.2.1 Schedule 2 of the Original Order is hereby deleted and replaced with the following:

Schedule 2A – Council-Owned Land (Vehicles and Structures)

(Applies to Clauses 2.2.1, 2.2.2, and 2.2.3)

- Any land owned by Westmorland and Furness Council to include car parks, verges, laybys, highways and streets maintained at the public expense.

Schedule 2B – National Trust Land (Unauthorised Fires, Barbeques, Vehicles and Structures)

(Applies to Clauses 2.1.1, 2.2.2 and 2.2.3)

- Blea Tarn – National Trust land, as shown edged red on the map titled “*Blea Tarn PSPO Map*” (Appendix 1)
- Coniston East Shore – National Trust land, as shown edged red on the map titled “*Coniston E Shore PSPO Map*” (Appendix 2)
- Windermere West Shore (North Section) – National Trust land, as shown edged red on the map titled “*Windermere W Shore PSPO Map North*” (Appendix 3)
- Windermere West Shore (South Section) – National Trust land, as shown edged red on the map titled “*Windermere W Shore PSPO Map South*” (Appendix 4)

Note: The areas listed in Schedule 2B are National Trust owned land and are included in this Order with the formal written consent of the landowner and following statutory consultation under section 72 of the Act.

3. General

This Variation Order is made in accordance with the procedure set out in sections 60 to 61 of the Act. The provisions of the Original Order shall continue in full force and effect, save as expressly varied by this Order.

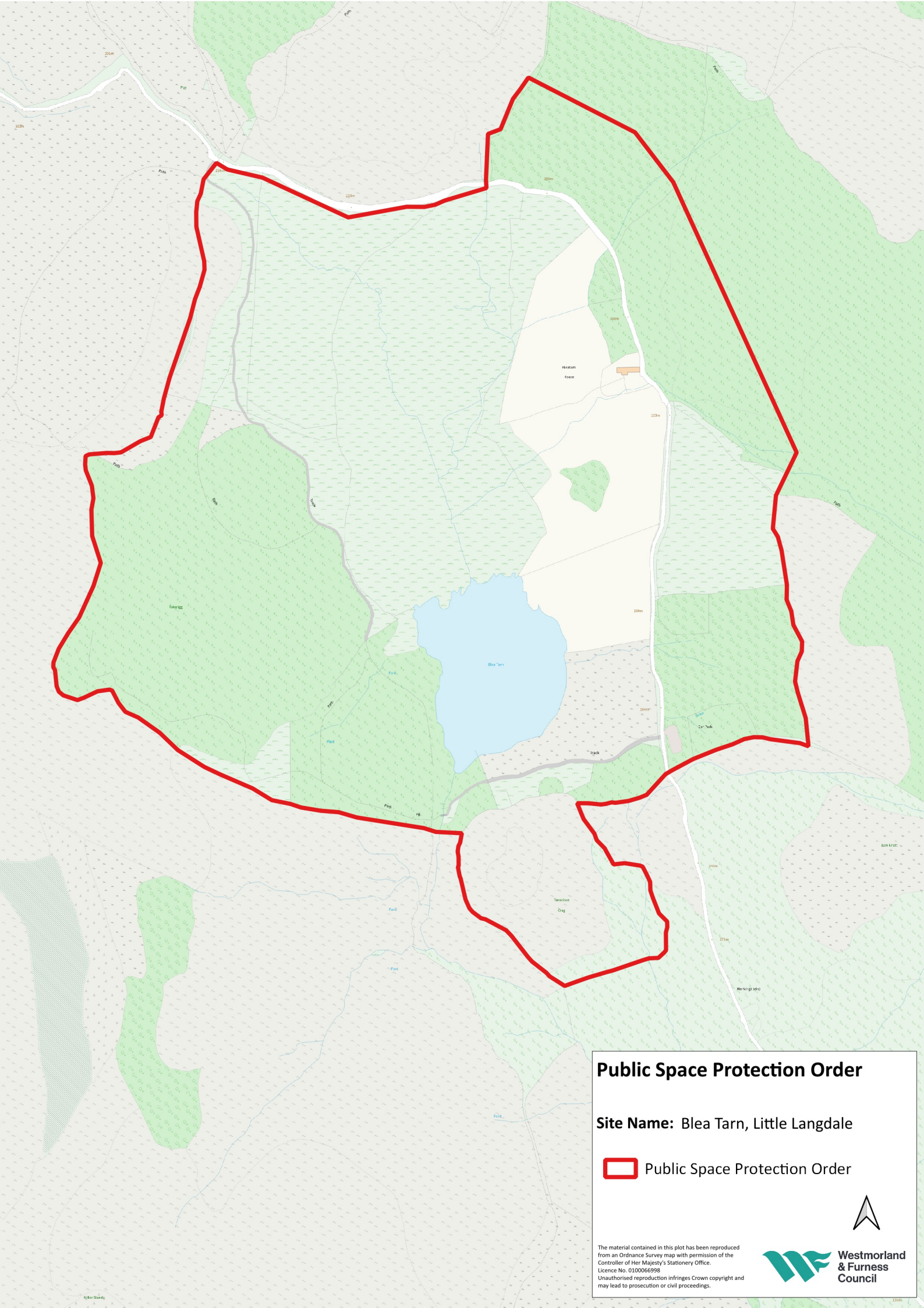

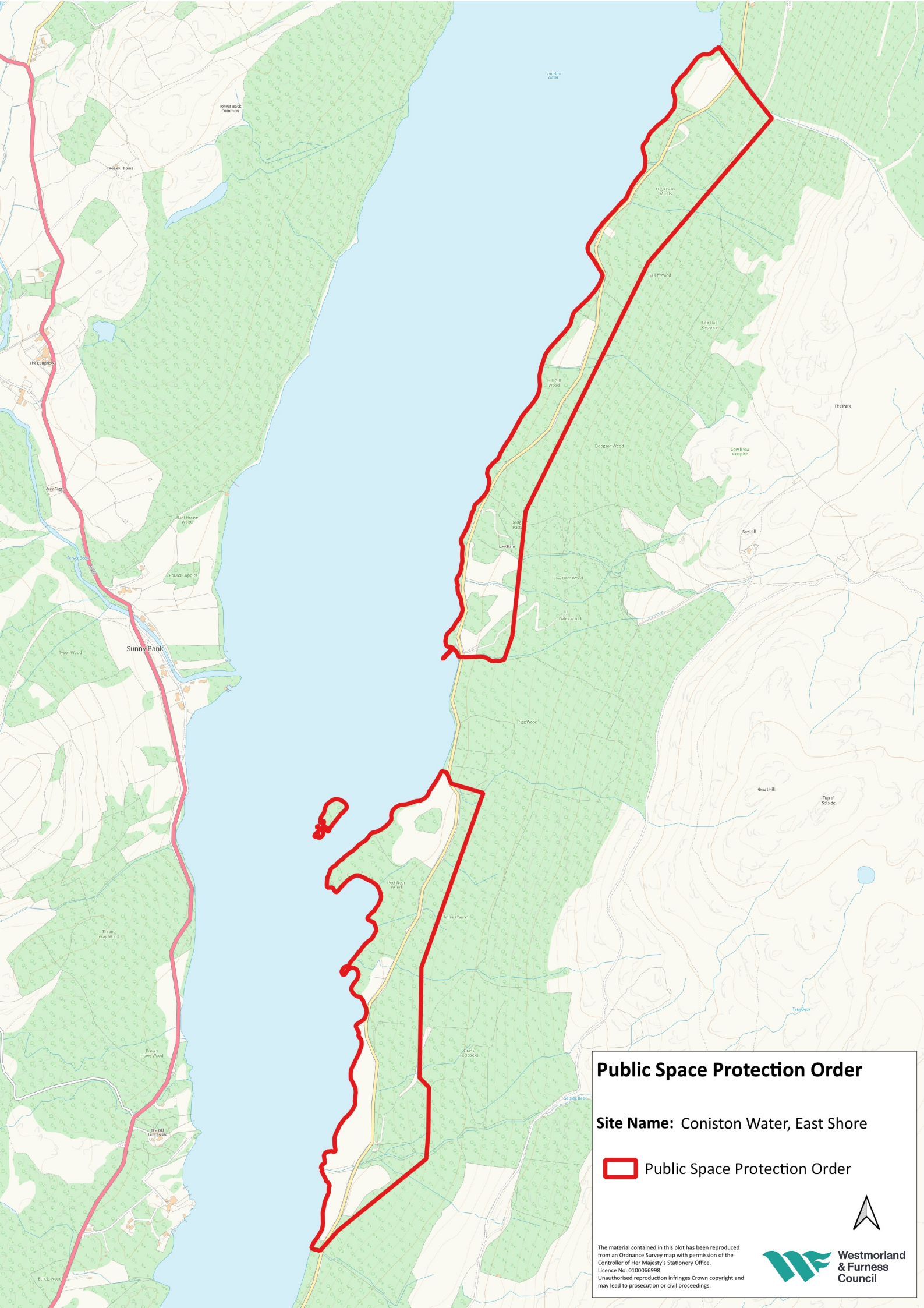
