

Commons Act 2006 – Section 19(2)(a)

NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Tim Cartmell** (“the Applicant”) to Cumberland Council as commons registration authority, under Section 19(2)(a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL20 Caldbeck Common.

A summary of the effect of the application is as follows:

The right to graze 99 units on Caldbeck Fell, comprising the whole of register unit CL20, is currently recorded as being attached to O.S. Nos. pt1506, pt1501, pt1497, 1494, 1495 and 1493 at entry 283.

This entry derived from entry 34 and was created following application number 1294 made by William Martin Peel.

The Applicant claims that a mistake was made by the commons registration authority when creating entry 283, as a result of application number 736 made by John Hickson, and that O.S. No. 1493 should not have been included in the particulars of the land to which the right is attached.

The Applicant states that that O.S. No. 1493 was not included in the transfer of land that resulted in application number 736 and conveyances and Land Registry title documents support this position.

If the application is granted, the registration authority will give effect to determination by cancelling entry 283 and replacing it with a new entry, showing the right to graze 99 units attaching to O.S. Nos. pt1506, pt1501, pt1497, 1494 and 1495 and creating a new supplemental map.


Any person wishing to make representations:

- must quote the Application No. **CA10/71**
- must state the name and postal address of the person making them, and the nature of that person’s interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and
- must be sent to: The Commons Registration Service, Lady Gillford’s House, Petteril Bank Road, Carlisle, Cumbria, CA1 3AJ or email: commons.registration@cumberland.gov.uk

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on **30 March 2026**.

Documents relating to the application are not available online although they can be provided on request. Requests should be sent directly to the Commons Registration Service using the contact details above. 


