

**WESTMORLAND AND FURNESS COUNCIL (BARROW ISLAND COMMUNITY
PRIMARY SCHOOL, AND BRAM LONGSTAFFE NURSERY SCHOOL,
BARROW IN-FURNESS) (PEDESTRIAN AND CYCLE ZONE) EXPERIMENTAL
ORDER 2026**

Westmorland and Furness Council hereby give notice that on 24 March 2026 it made the above Experimental Order under Sections 9 and 10 of the Road Traffic Regulation Act 1984 and all other enabling powers.

1. This Order will come into operation on 22 April 2026, and its effect will be to:
 - (a) introduce a Pedestrian and Cycle Zone (“the Zone”) to prohibit any motor vehicle from proceeding along the length of road specified in the Schedule 1 to this Order, during the days and times specified therein.
 - (b) Parking bay is prohibited along the length of road specified in the Schedule 2 to this Order, during the days and times specified therein.

2. There are exemptions in the Order to enable motor vehicles to enter the Zone, if the vehicle is being used: -
 - (c) for Fire Brigade, Police or Ambulance Purposes;
 - (d) in connection with the carrying out on, or on premises situated on or adjacent to that length of road, of any of the following operations, namely:-
 - (i) the removal of obstructions to traffic;
 - (ii) for, or in connection with, mechanical road cleansing or mechanical refuse collection;
 - (iii) the maintenance, improvement or reconstruction of roads;
 - (iv) the laying, erection, alteration or repair in, or in land adjacent to, that length of road of any sewer or of any main pipe or apparatus for the supply of water, gas or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984.
 - (e) in the service of a Local Authority or a water or sewerage undertaker which is being used in pursuance of statutory powers or duties;
 - (f) in the service of or employed by the Post Office to be used for the purpose of delivery or collection of postal packets as defined in the Postal Services Act 2000 to or from premises located within the Zone;

- (g) in use as a School Bus or for school transport purposes and being contracted to carry persons to or from a school located within the Zone
 - (h) for the conveyance of persons, goods or burden to or from premises situated within or accessible only from the Zone;
 - (i) by any vehicle displaying a disabled badge, being driven by or carrying a disabled person to uplift or set down pupils attending Barrow Island Community Primary School and Bram Longstaffe Nursery School within the Zone.
 - (j) if it is employed by a local bus service operator and the vehicle is in use during a scheduled service as a Bus as defined in Regulation 22 of the Traffic Signs Regulations and General Directions 2016
 - (k) in connection with any funeral undertaking from any premises within the Zone.
2. Full details of the sealed Order, together with a plan showing the length of road concerned and a statement of the Council's reasons for making the Order may be inspected during normal opening hours at Westmorland and Furness Council, Sowerby Woods Depot, Barrow in Furness, Cumbria, LA14 4RD and at Barrow Library, Ramsden Square, Barrow-in-Furness, LA14 1LL. 3. If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or any instrument made there under has not been complied with in relation to the Order, you may within six weeks of 24 March 2026 apply to the High Court for this purpose.

Pedestrian and Cycle Zone – Between 8.20 am and 9.00 am and between 3:10 pm and 3.50 pm each day, Monday to Friday inclusive, during Term Time Only

Street Name	Town	Restricted Length
Farm Street	Barrow-in-Furness	From its junction with Dundee Street, extending in a south-easterly direction for a total distance of 60m.

Prohibition of Limited Waiting Parking Place (At All Times) 2 hours no return within 2 hours (permit holders exempt)- Between 8.20 am and 9.00 am and between 3:10 pm and 3.50 pm each day, Monday to Friday inclusive, during Term Time Only

Street Name	Town	Restricted Length
Farm Street	Barrow-in-Furness	Farm Street, Barrow-in-Furness, the south-west side from a point 51 metres south-east of its junction with Trinity Street for a distance of 34 metres in a south-easterly direction
