

Commons Act 2006 – Section 8

NOTICE OF APPLICATION FOR THE APPORTIONMENT OF A RIGHT OF COMMON

Notice is hereby given that an application was made by **Michael John Armstrong** and **Mark David Armstrong** (“the Applicants”) to Westmorland and Furness Council, as Commons Registration Authority, under Section 8 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to entry number 4 of common land register unit CL80 Knock Fell and entry number 19 of common land register unit CL82 Dufton Fell.

A summary of the effect of the application is as follows:

The right to graze (a) 350 ewes with their followers and (b) 120 hogs over the whole of the land comprised in register unit CL80 and CL82 is attached to land at Red House Farm, Knock, Westmorland comprising O.S. plots numbered 1, 8, 23, 32, 33, 56, 59, 80, 81, 82, 83, 86, 115, 117, 123, 126, 129, 143, 144, 147, 151, 154, 210, 210a, 211, 286, 288 and 289 together with part O.S. plot No. 108, all on the O.S. Map (Edition of 1915) of the parish of Long Marton, Westmorland (“the Right”).

Pursuant to the division of the land to which the Right is attached, the Applicants seek by this application to register apportionment of the Right appropriate to the parts of land transferred and now in their ownership.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by making the following amendment to the commons register:

1. Entry number 4 of CL80 will be deleted and reference made to the new corresponding entries.
2. Entry number 19 of CL82 will be deleted and reference made to the new corresponding entries.
3. Addition of supplemental maps.
4. The following entries will be made to the rights section of the commons registers to show the proportionate apportionment of the Right to the Applicants:
 - a. The right to graze (a) 10.94 ewes with their followers and (b) 3.75 hogs over the whole of the land comprised in register unit CL80 and CL82 is attached to land at part of Red House Farm, Knock, Westmorland comprising O.S. plots numbered 86, 129, pt143 and 147 together with part O.S. plot No. 108, all on the O.S. Map (Edition of 1915) of the parish of Long Marton, Westmorland as shown coloured blue on the proposed supplemental map.

- b. The right to (a) 339.06 ewes with their followers and (b) 116.25 hogs over the whole of the land comprised in register unit CL80 and CL82 is attached to land at part of Red House Farm, Knock, Westmorland comprising O.S. plots numbered 1, 8, 23, 32, 33, 56, 59, 80, 81, 82, 83, 115, 117, 123, 126, pt143, 144, 151, 154, 210, 210a, 211, 286, 288 and 289, all on the O.S. Map (Edition of 1915) of the parish of Long Marton, Westmorland as shown coloured orange on the proposed supplemental map.

Any person wishing to make representations:


- must quote the Application No. **CA3/61**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on **08 June 2026**.

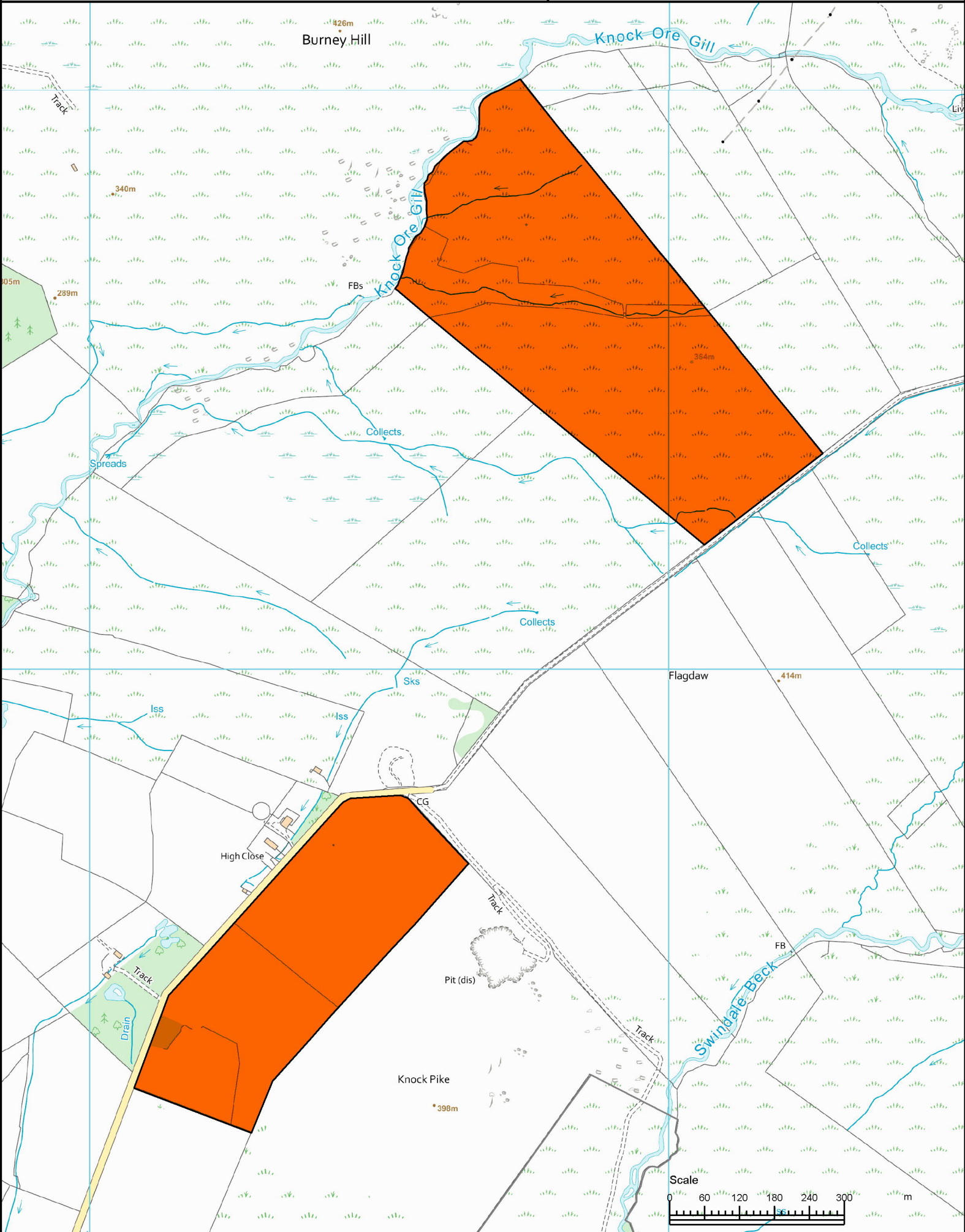
