General Description of the Premises

Fell Good Village Shop is a small, community-focused retail premises selling deli foods, takeaway foods and drinks, produce, general and whole foods, household items, toiletries and gifts. On successful receipt of an alcohol premises license a modest range of alcohol including local craft type beers, wines, and spirits will be offered for sale.

On-sales will consist of supervised paid and free tastings with food, during which drinks may be purchased. Due to limited space these will be small controlled events. At other times, customers may purchase a glass of wine, beer or cider for consumption in the shop. Alcohol consumption will remain incidental to the retail function of the premises. The shop will not operate as a bar. Seating is limited and managed to ensure a calm and controlled environment, with alcohol consumption remaining incidental to the retail function of the premises.

The customer area includes a front shop, a rear shop, with a connecting passage. Alcohol will mainly be displayed in the front shop area, with additional display locations used as required within the licensed premises, provided these areas can be effectively monitored.

The shop will generally operate between 08.30 and 18:00, with the option to open later during busy periods such as holiday seasons and to enable tasting events. The premises license application is therefore for hours between 8.30 a.m. and 10 p.m.

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

As the nominated Designated Premises Supervisor, I will take reasonable and proportionate steps to reduce the risk of theft, disorder, criminal activity, public nuisance, and harm to children, through responsible management and appropriate supervision.

The premises will be managed in full adherence to the four licensing objectives as set out below.

b) The prevention of crime and disorder

Staff involved in the sale of alcohol will be authorised by myself as the designated premises supervisor and will receive appropriate training on the responsible sale of alcohol, including age-verification, Challenge 25, the relevant legal responsibilities and the licensing objectives, with updates provided as required.

Staff will understand their responsibilities regarding age-restricted sales, preventing sales to intoxicated persons, and complying with the permitted hours and conditions of the premises licence.

Incident & Refusals Recording A diary will be used to note refusals of alcohol sales or any relevant incidents as appropriate.

c) Public safety

The premises will be operated with appropriate attention to general health and safety, including maintaining clear access routes, managing customer flow within the shop, and ensuring that fixtures, fittings and equipment are used safely.

Fire safety measures appropriate to a small retail premises will be maintained, and any issues affecting public safety will be addressed promptly as part of normal day-to-day management.

d) The prevention of public nuisance

The premises will be operated in a way that minimises any risk of public nuisance. Deliveries, waste disposal and customer activity will be managed in a considerate manner appropriate to a small village shop, and any issues that arise will be dealt with promptly as part of normal day-to-day management.

Tasting events will be small, supervised and managed responsibly to avoid nuisance, and customers may be reminded to leave quietly where appropriate.

Any music played will be kept at a level appropriate for a small retail environment and managed so as not to cause disturbance to neighbours.

e) The protection of children from harm

A Challenge 25 age-verification policy will be operated to prevent under-age sales. Anyone who appears under 25 attempting to purchase alcohol will be asked to provide valid photographic ID such as a passport, photocard driving licence or PASS-accredited card. Signage may be displayed at the point of sale to advise customers that Challenge 25 is in operation.

Staff involved in the sale of alcohol will be authorised by myself, as the Designated Premises Supervisor, and will understand their responsibilities regarding age-restricted products and refusals noted in the diary

During tasting events, alcohol will only be provided to persons aged 18 or over and events will be supervised.

Non-alcoholic options will be available for any under-18s who may be present, who must be accompanied by an adult.

 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

- any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

- 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Home Office online right to work checking service.

As an alternative to providing a copy of original documents, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth, will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be shared digitally. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copies of documents as set out above.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

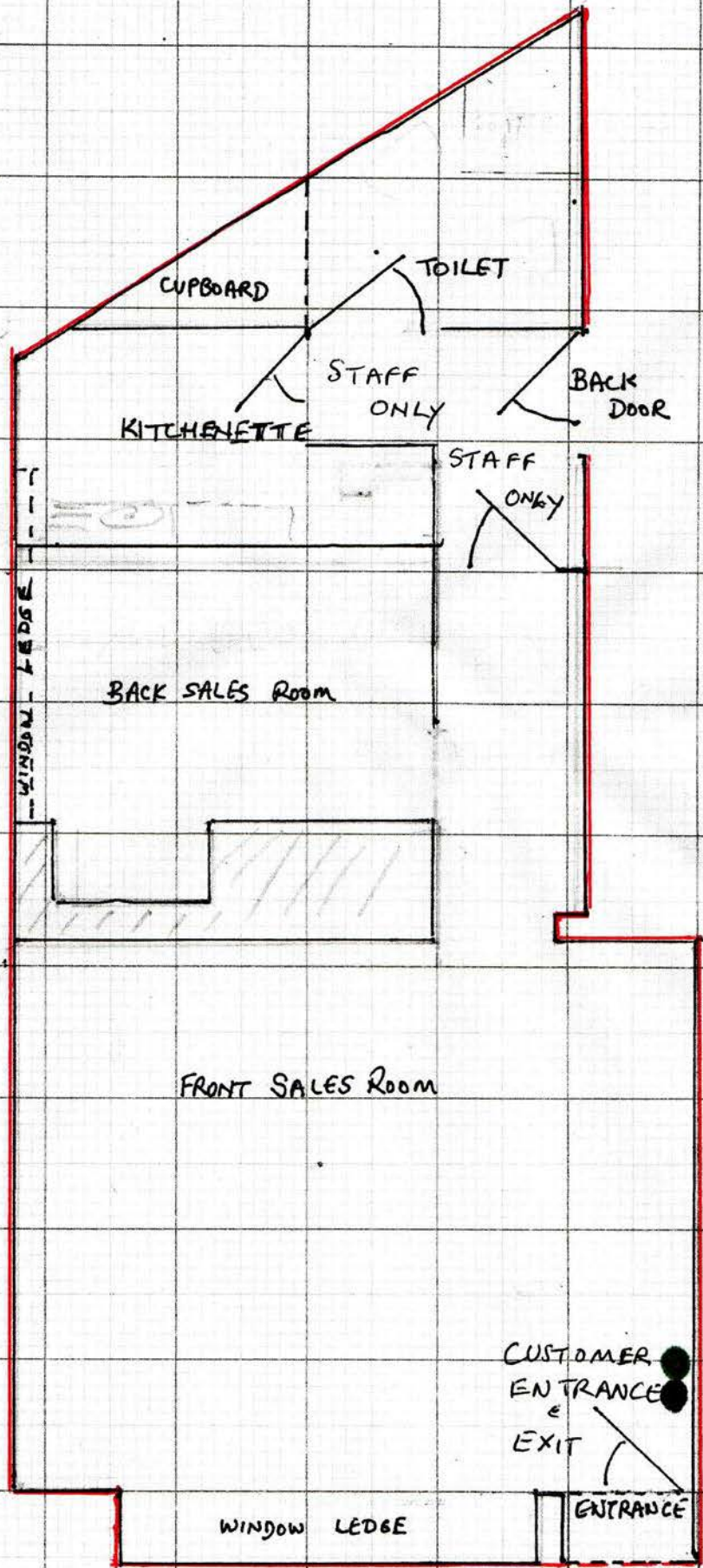
