Application for the apportionment of a right of common

NOTICE OF DETERMINATION

Application Number: CA3/64

Notice is hereby given that Westmorland and Furness Council, as the Commons Registration Authority (“the CRA”), has considered an application submitted by **Michael John Armstrong** and **Mark David Armstrong** (“the Applicants”) seeking to apportion the right of common recorded at entry number 19 of common land register unit CL322 The Rigg, Blencarn (“the Right”), and to register the apportionment in the register.

Decision


The CRA resolved to accept the application to amend the registers by registering the apportionment of the Right.

Reasons

The Commons Registration Officer assessed the application and found it to be duly made under the criteria prescribed by the relevant regulations and guidance. No objections were received against the application.

Outcome

The rights section of the register for CL322 The Rigg, Blencarn has been amended to show the Right as apportioned in accordance with the Notice of Application attached to this decision.

NOTICE OF APPLICATION FOR THE APPORTIONMENT OF A RIGHT OF COMMON

Notice is hereby given that an application was made by **Michael John Armstrong** and **Mark David Armstrong** (“the Applicants”) to Westmorland and Furness Council, as Commons Registration Authority, under Section 8 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to entry number 19 of common land register unit CL322 The Rigg, Blencarn.

A summary of the effect of the application is as follows:

The right to graze 200 sheep and 50 hogs on Blencarn Rigg comprising the whole of the land in this register unit is attached to O.S. Nos. 99, 100, 101, 31, 47, 93, 92, 90, 95 and 97 (“the Right”).

Pursuant to the division of the land to which the Right is attached, the Applicants seek by this application to register apportionment of the Right appropriate to the parts of land transferred and now in their ownership.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by making the following amendment to the commons register:

1. Entry number 19 of CL322 will be deleted and reference made to the new corresponding entry.
2. Addition of a supplemental map.
3. The following entry will be made to the rights section of the commons register to show the proportionate apportionment of the Right to the Applicants:
 - a. The right to graze 1.98 sheep and 0.48 hogs on Blencarn Rigg comprising the whole of the land in this register unit is attached to O.S. Nos. pt31, pt93 and pt92 as shown coloured pink on the proposed supplemental map.
 - b. a. The right to graze 198.10 sheep and 49.52 hogs on Blencarn Rigg comprising the whole of the land in this register unit is attached to O.S. Nos. 99, 100, 101, pt31, 47, pt93, pt92, 90, 95 and 97 as shown coloured orange on the proposed supplemental map

Any person wishing to make representations:


- must quote the Application No. **CA3/64**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on **8 June 2026**.

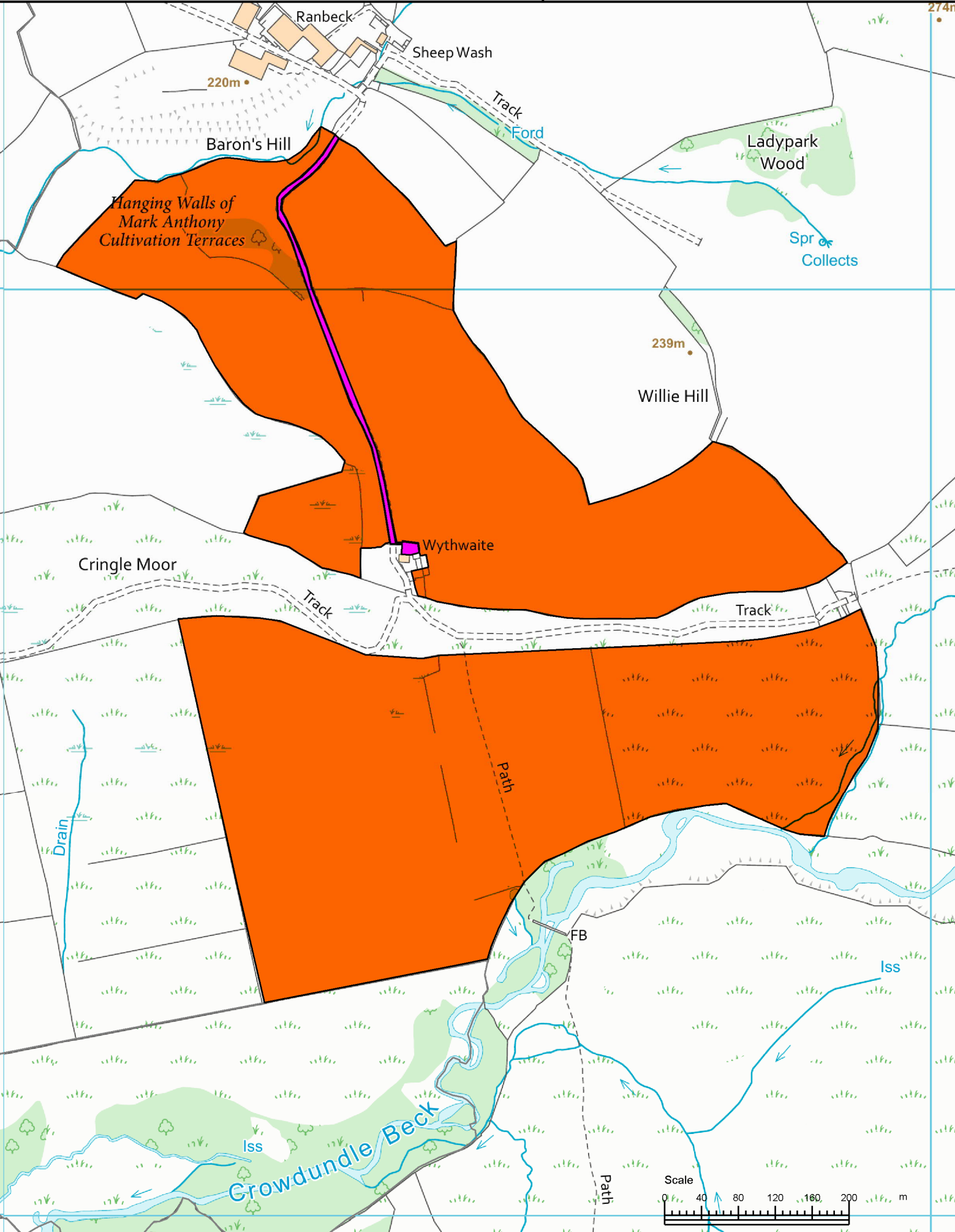
