Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The premises will operate under a nominated Designated Premises Supervisor (Roy Clarke). A sufficient number of trained staff will be on duty at all times to ensure safe and compliant operation. The premises will be managed in full adherence to the four licensing objectives as set out below.

b) The prevention of crime and disorder

CCTV

- A comprehensive digital colour CCTV system will cover all entry/exit points, internal circulation areas, and any external customer spaces.
- The system will be maintained, fully operational, and recording at all times when the premises are open.
- Recordings will be of evidential quality, capable of facial identification, and retained for a minimum of 31 days.
- Recordings will display the correct time and date.
- Copies will be made available to any Responsible Authority within 48 hours, subject to Data Protection requirements.
- Management will ensure sufficiently trained staff are available to download footage on request.

Staff Training

All staff will receive documented training at the commencement of employment covering:

- retail sale of alcohol,
- age verification
- license conditions
- permitted activities
- licensing objectives
- opening times
- conflict management
- drug awareness
- vulnerability
- emergency procedures
- legal responsibilities.

Training will be refreshed at least annually and recorded.

Training records will be kept for at least one year and made available to Responsible Authorities.

Incident & Refusals Recording

- A documented incident log will record refusals, ejections, disturbances, anti-social behavior, seizures, and police interactions.
- Logs will be retained for at least one year.

Door Supervision

- Door supervisors will be deployed when required by risk assessment or licence conditions.
- All door staff will be SIA-registered and maintain a sign-in/out log.
- Door staff will monitor occupancy and prevent entry once maximum capacity is reached.

Drugs Policy

- A zero-tolerance approach to drugs will be adopted, with regular toilet checks, signage, and cooperation with police.
- A written drugs policy will be agreed with the Police.
- A lockable drugs box will be used, with contents handed to police.

Dispersal

- A dispersal policy will ensure customers leave safely and quietly.

c) Public safety

- The premises will be checked before opening to ensure safety measures are in place.
- A full fire risk assessment will be maintained, with extinguishers, alarms, and emergency lighting tested regularly.
- Capacity limits will be adhered to.
- Staff will be trained in evacuation, assembly points, and crowd management.
- Electrical and gas installations will be inspected at required intervals.
- First aid kits will be available, with trained first aiders on duty at peak times.
- A defibrillator will be purchased and kept on site at all time with staff given full training on how to operate.
- Clear access/egress routes and unobstructed fire exits will be maintained.
- Glassware will be managed safely, with polycarbonate used where required.
- A documented maintenance schedule will be kept.
- Bottles, glasses, and rubbish will be removed regularly.

d) The prevention of public nuisance

- Suitable and conspicuous notices will be displayed at entrances and exits requesting patrons to minimise noise when smoking and/or leaving the premises.
- All windows and external doors will be kept closed at any time when regulated entertainment takes place, except for access/egress.
- No noise or vibration shall cause a nuisance.
- Noise management will include boundary noise checks at the nearest noise sensitive locations.
- Noise monitoring records will be kept for 6 months.
- Smoking areas will be managed to minimise disturbance.
- Deliveries, waste collections, and bottle disposal will occur at reasonable hours to avoid disturbance.
- External lighting will be positioned to avoid glare or light spill onto neighbouring properties.
- Any outdoor areas will be managed with limits on capacity, hours of use, and amplified sound.
- A dispersal policy will encourage customers to leave quietly, supported by staff presence at closing time and signage requesting considerate behaviour.
- Alcohol may only be taken off-site in sealed containers.
- Open containers may only be consumed in delineated external licensed areas.

e) The protection of children from harm

- The licence holder will operate a Challenge 25 Age Verification Policy.
- Prominent signage will be displayed at the point of sale indicating that Challenge 25 is in operation.
- Acceptable forms of ID will include passport, photo-card driving licence, PASS-accredited cards, and military ID (until alternative secure identification technology is adopted).
- A refusals register will be maintained and checked regularly by management.
- Children will only be permitted on the premises during specified hours and in designated areas, subject to risk assessment.
- Staff will be trained to recognise signs of child sexual exploitation (CSE) and how to escalate concerns.
- Alcohol will not be sold for consumption by anyone under 18.
- Soft drinks will be clearly distinguished from alcoholic products.
- No gaming machines will ever be added to the premises.

 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the

audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

<https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth, will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be shared digitally. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copies of documents as set out above.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

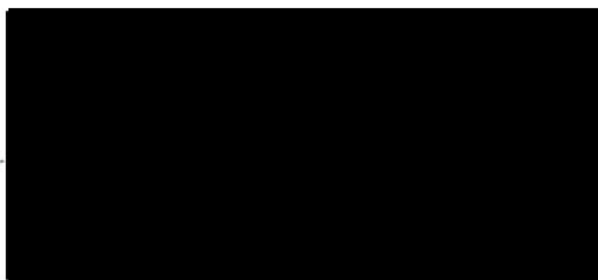
