Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

Green Lane Co is a country clothing, outdoor and gifting retailer. The sale of alcohol will be ancillary to the main retail business and will consist of sealed containers for consumption off the premises only.

The premises will actively promote the four licensing objectives through effective management, staff training, clear operating procedures and regular monitoring of compliance. Staff will be trained in licensing law, age verification procedures and the responsible retailing of alcohol.

The premises will operate a Challenge 25 policy, maintain appropriate records where necessary, display clear signage relating to age-restricted sales and refuse any sale where legal requirements are not met. The premises will be managed in a manner that promotes public safety, prevents crime and disorder, minimises nuisance and protects children from harm.

Management will work closely with responsible authorities where required and will review procedures periodically to ensure the licensing objectives continue to be upheld.

b) The prevention of crime and disorder

The premises will take all reasonable steps to prevent crime and disorder. Alcohol sales will be limited to sealed containers for consumption off the premises only.

A Challenge 25 age verification policy will be operated, and staff will be trained in the responsible sale of alcohol and the prevention of underage sales. Acceptable forms of identification will be requested where appropriate.

The premises will maintain good standards of supervision and management at all times. Staff will be instructed to refuse sales to any person who appears intoxicated or where there is reason to believe alcohol may be purchased on behalf of a person under the legal age.

Any incidents of crime, disorder or refused sales will be recorded where appropriate and reviewed by management. The premises will cooperate with the police, licensing authority and other responsible authorities to ensure the licensing objectives are upheld.

The sale of alcohol will remain ancillary to the primary business of country clothing, outdoor equipment and gifting, reducing the likelihood of crime and disorder associated with dedicated alcohol retailers.

c) Public safety

The premises will comply with all relevant health and safety legislation and maintain appropriate fire safety measures, emergency procedures and first aid provisions. All escape routes, exits and access points will be kept clear and unobstructed.

Staff will receive appropriate training and will be familiar with emergency procedures. The premises will be maintained in a safe condition, with regular checks carried out to identify and address any potential hazards.

Alcohol sales will be limited to sealed containers for consumption off the premises only. The premises will not permit on-site consumption of alcohol, helping to minimise any risks associated with intoxication.

Management will regularly review safety procedures and take all reasonable steps to ensure the premises remain safe and accessible for all customers and staff.

d) The prevention of public nuisance

Alcohol sales will be limited to sealed containers for consumption off the premises only. No on-site consumption of alcohol will be permitted, and the premises will not host events, entertainment, live music or activities likely to cause disturbance.

The premises will operate during reasonable retail trading hours, and staff will monitor the area immediately outside the premises to discourage anti-social behaviour where appropriate.

Waste and recycling will be managed responsibly, with collections arranged at suitable times to minimise disturbance. Deliveries will be scheduled during normal business hours wherever possible.

Management will respond promptly to any concerns raised by local residents, businesses or responsible authorities and will take appropriate action to prevent any recurring issues.

e) The protection of children from harm

A Challenge 25 age verification policy will be operated at all times. Any customer who appears to be under the age of 25 will be required to provide acceptable photographic identification before alcohol is sold. Acceptable forms of identification will include a passport, photocard driving licence or PASS-approved proof of age card.

Staff will receive training on age-restricted sales, recognising valid identification and preventing proxy purchases. Alcohol will not be sold to anyone who is under the legal age, or where there is reason to believe the alcohol is being purchased on behalf of a minor.

Clear signage relating to age-restricted sales and the Challenge 25 policy will be displayed at the point of sale. Any refusals of alcohol sales will be recorded and reviewed by management where appropriate.

The premises will remain a family-friendly retail environment, with the sale of alcohol being ancillary to the primary business of country clothing, outdoor equipment and gifting.

Notes for Guidance

 - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.

- a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
- a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

As an alternative to providing a copy of original documents, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.
