no other ways had been dedicated as highways over Rigmaden Estate

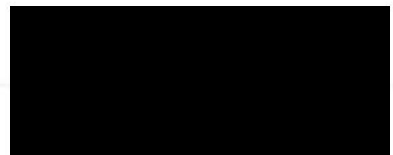

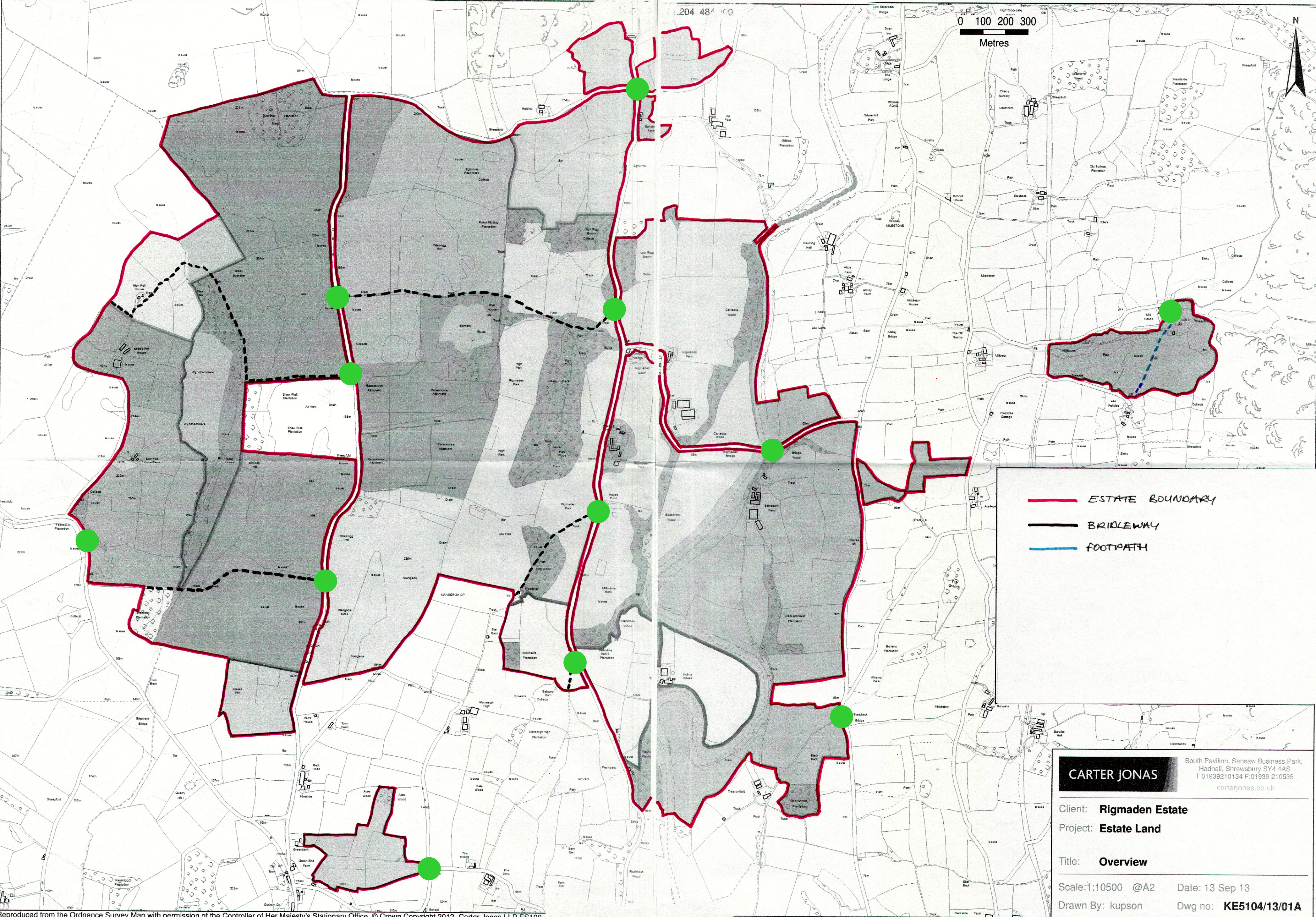
