

Commons Act 2006 – Section 8

NOTICE OF APPLICATION FOR THE APPORTIONMENT OF A RIGHT OF COMMON

Notice is hereby given that an application has been made by **Michael John David Cavanagh** (“the Applicant”) to Westmorland and Furness Council, as Commons Registration Authority, under Section 8 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014. The application relates to entry number 18 of common land register unit CL41 Roundthwaite Common (Tebay).

A summary of the effect of the application is as follows:

The right to graze (a) 53 ewes and followers (b) 22 hogs and (c) 3 horses over the whole of the land comprised in this register unit is attached to Part of Town Head Farm, Roundthwaite comprising O.S. plots numbered 396, 396a, 397, 426, 426a and 476 on the O.S. Map (Edition of 1915) of the parish of Tebay (“the Right”).

Pursuant to the division of the land to which the Right is attached, the applicants seek by this application to register apportionment of the Right appropriate to the part of land transferred.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by making the following amendment to the commons register:

1. Entry number 18 will be deleted and reference made to the new corresponding entries.
2. Addition of supplemental maps.
3. The following entries will be made to the rights section of the commons register to show the proportionate apportionment of the Right to (a) the Applicants and (b) the remainder of the right:
 - a. The right to graze (a) 39.11 ewes and followers (b) 16.24 hogs and (c) 2.21 horses over the whole of the land comprised in this register unit is attached to land formerly part of Town Head Farm, Roundthwaite comprising O.S. plots numbered 396, 396a, pt426 and 426a on the O.S. Map (Edition of 1915) of the parish of Tebay (and as shown coloured orange on the proposed supplemental map).
 - b. The right to graze (a) 13.89 ewes and followers (b) 5.76 hogs and (c) 0.79 horses over the whole of the land comprised in this register unit is attached to land formerly part of Town Head Farm, Roundthwaite comprising O.S. plots numbered 397, pt426 and 476 on the O.S. Map (Edition of 1915) of the parish of Tebay (and as shown coloured orange on the proposed supplemental map).

Any person wishing to make representations:

- must quote the Application No. **CA3/69**
- must state the name and postal address of the person making them, and the nature of that person’s interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

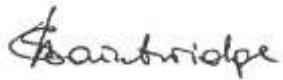

Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on **02 November 2026**.
